

Each and every year, a special form (See Enclosure Four (4) on MCLNAT website) must be filled out by the individual member and signed by the Detachment Commandant and Detachment Adjutant/Paymaster, then mailed/emailed to the National Junior Vice

Commandant. Recruiting Awards will be issued as follows:

- (a) A Citation will be given to those members who have recruited 5-24 members during the year.
- (b) A National Recruiters Medal-Bronze and a Distinguished Service Award Citation (signifying the accomplishment) will be presented to those members who recruited 25-49 members during the year.
- (c) A National Recruiters Medal-Silver and a Distinguished Service Award Citation (signifying the accomplishment) and a plague will be presented to those members who recruited 50 plus members during the year.
- (d) The top Recruiter of the Year, the one individual member that has recruited the most members through his/her individual efforts will be presented the National Recruiters Medal-Gold (appropriately engraved), and a plague in the shape of the United States with his/her name engraved thereon and the Distinguished Service Award Certificate (signifying the accomplishment).

It is that time of the year when Detachments start the election process for the coming year. National and Department Bylaws and Administrative Procedures mandate that each Detachment must hold their annual elections between October 1 and May 15. Both National and Department have reporting requirements that must be followed. I have listed information below that will help your Detachment with the process. Installing Officer — The Officers below are the only officers that can install your Detachment: National Commandant, Elected National Officer, Past National Commandant, Department Commandant, Elected Department Officer, Past Department Commandant, Detachment Commandant, Past Detachment Commandant Note: If you are requesting the Department Commandant or an Elected Department Officer. Required reports: Report of Officer Installation — This form is available by going to the National Headquarters website, www.mclnational.org. Type in "forms" in the search box and then "click" on Officer Installation. This will bring up the Report of Officer Installation form. Type in all the appropriate information required. Then print the completed form for your files. Obtain the signature of the Installing Officer and the individual completing the form and mail or email the completed form to the Department Adjutant within 10 days of the installation.

## Dept. Paymaster

**Paymasters:** There is an easier, faster and cheaper way to submit dues transmittals. You should be using it.

A few months ago, Jim Breen replicated the system that many of the Departments have been using to submit dues and transmittals to National. Our Detachments are now able to use it to submit dues payments and transmittals. This system eliminates mailing delays and lost mail pieces by sending both the documents and payments electronically. Not only that – it's cheaper. If you mail a transmittal and a check, the first class postage is 66 cents. If you use the dreaded long-form transmittal, which consists of several wasted pages, it costs a minimum of \$1.06, plus the envelope. If you use this new system, it only cost 25 cents, regardless of how many pages or dues payments are involved.

Here's how to use it: 1) Go to the Department web site (<u>www.mcleaguesc.ora</u>); 2) Click on the red bar "Online Dues Transmittal"; 3) After you have completed your transmittal form (typewritten, not handwritten, hopefully) enter your contact info, then use the drop-down boxes to select the number of renewals, new members, Associate renewals, etc. This will automatically calculate the amount due – including the \$5 fee which goes to the Department. 4) Below the drop-down boxes, click on the box "Choose File", that will upload your transmittal and other supporting documents (such as a New Member Application). 5) After you click on the "Continue Registration" you will be taken to the next page which allows you to select your method of payment.

<u>Caution</u>: if you select Credit or Debit card as your method of payment, your card will be charged an additional fee of about 3%. **Your best bet is to select ACH**. That will bring up boxes that allow you to enter you checking account number and the routing number. That transaction will add only a 25 cent fee to the amount of the dues payments. You'll see a confirmation of the total amount to be charged and the date the funds will be charged to your bank account. (*It may be a few days later before you actually see those charges reflected on your bank statement*). After reviewing the confirmation, you click the button to submit and you're done. You'll receive another confirmation and receipt indicating that the transaction has been submitted.

The Department paymaster receives these transactions instantly. I follow the same process to submit payments to National. Altogether, this process eliminates at least a week in delays in regular mail. You have hardcopy confirmation that your payment was submitted, and we all have a better audit trail.

We currently have four Detachments that have adopted this new process. You should try it.... I think you'll find that it's a much better process. If you have questions, or want assistance to walk thru the process, contact me. Jerry Holt, (973) 897-9251, or jerryholt813@gmail.com.

#### **VSO Stipend for Honor Guard Funeral Services**

In June 2022, South Carolina Governor Henry McMaster signed legislation (Act No. 225) entitled Veterans Service Organization Burial Honor Guard Support Fund, which provides a stipend to congressionally chartered veterans service organizations that provided an honor guard burial detail at the funeral of a qualifying South Carolina veteran. The minimum stipend is fifty dollars (\$50) per funeral detail, but may not exceed the per funeral cap established by the Secretary of the Department of Veterans' Affairs. (The current cap is \$100 per funeral).

To claim the stipend, you must download and submit a Request for Reimbursement to the Secretary of Veterans Affairs no later than the 15th of the month following the date the funeral was conducted. You can find the form on the SC Department of Veterans Affairs website, www.scdva.sc.gov. In the search box, type the word "documents" then look for "STANDARD OPERATING PROCEDURE. Veteran Service Organization (VSO) Burial Honor Guard Support fund."

Prior to submitting the first request for reimbursement, you'll need to obtain a State Vendor Number for the Honor Guard unit. A link to the instructions for this process is included in the form downloaded previously. As you go through that process, you may find it worthwhile to also sign up for direct deposit into the Honor Guard's bank account.

Once you've registered as a vendor and prepared your reimbursement request form, you should submit the form electronically to VSOHonors@scdva.sc.gov. (This is not the address that is indicated on the form, but it is the one that will ensure that the form reaches someone who will take action on it).





## **VETERAN AFFAIRS**

The Staff Sergeant Parker Gordon Fox Suicide Prevention Grant Program (SSG Fox SPGP) is preparing to enter its third year. VA published the Notice of Funding Opportunity (NOFO) for the SSG Fox SPGP on January 26, 2024. The NOFO can be viewed at the Federal Register and at grants.gov. The NOFO provides information about the program, eligibility, and the award process.

Existing SSG Fox SPGP grantees must submit an application for grant renewal. Eligible organizations with a concept to help prevent Veteran suicide may apply as new applicants.

The SSG Fox SPGP, part of the Commander John Scott Hannon Veterans Mental Health Care Improvement Act, is a community-based grant program that gives financial assistance to eligible entities to provide or coordinate the provision of suicide prevention services for certain Veterans and their families. The SSG Fox SPGP advances VA's mission of using a public health model that combines partnerships with the community to implement tailored, local suicide prevention plans while also focusing on evidence-based clinical strategies for intervention.

In 2023, the SSG Fox SPGP awarded \$52.5 million to 80 awardees in all 43 states, Washington, D.C., Guam, and American Samoa. In FY24, \$52.5 million will be available for SSG Fox SPGP grants for FY25 services.

The SSG Fox SPGP NOFO has two funding priorities. Under Priority 1, VA provides opportunity for funding to those entities with existing SSG Fox SPGP awards. Those entities may apply for an amount equal to or less than its current award. Under Priority 2, new organizations can apply for grants worth up to \$750,000. Following the selection of existing grantee applicants (Priority 1), should any funds remain, new applicants will be scored, ranked, and awarded according to NOFO Priority 2.

SSG Fox SPGP applications are due on April 26, 2024. In advance of this deadline, VA will provide a recorded webinar and host a subsequent live webinar to address questions for both renewing and new applicants.
